Preamble

It is agreed by the Company and the Proposer (the “**Parties**”) that the Application along with the personal statement and the declaration together with any report or other document leading to the issuance of this Policy shall form the basis of this contract of insurance.

It is further agreed by and between the Parties that these terms and conditions, any endorsement or a separate instrument executed by the Company in connection with this Policy and any special provisions subject to which this Policy has been issued by the Company and any schedules, annexure, endorsement and/or addendums hereto shall together form part of this Policy.

It is also agreed that this Policy shall be governed by the laws of India in force from time to time and all premiums and benefits shall be payable in Indian Rupees only. The benefits and the Premiums payable under this Policy will be subject to applicable taxes and other statutory levies as may be applicable from time to time and such applicable taxes, levies etc will be recovered directly and completely from the Policyholder.

1. Definitions

Term	Meaning
Accident	Refers to a sudden, unforeseen and involuntary event caused by external, visible and violent means
Age	The age of the Life Insured at last birthday
Application	Refers to the proposal form as defined under IRDAI (Protection of Policyholders' Interest) Regulations, 2017 and amendments thereto, completed, signed and submitted by the Proposer to the Company for obtaining insurance coverage under this Policy

Interpretation: In this Policy Document, where appropriate, references to the singular will include references to the plural and references to one gender will include references to the other.

PART C

1(A). Benefits payable under Your Policy

a. Death Benefit

- i. In case of death of the Life Insured during the policy term provided the policy is in-force (including fully paid-up policies) and all premiums are received by Us, the Company will pay the following benefits to the Policyholder/Nominee/ Beneficiary, as the case may be and the policy will terminate immediately. The death benefit will as per the Benefit Option chosen by the Policyholder at the policy inception.

<u>Benefit Option</u>	<u>Benefit payable</u>
Option 1 – Income Benefit	Sum Assured on Death (as defined below) plus Cash Bonus, if declared for the year of death plus Terminal Bonus, if declared
Option 2 – Lumpsum Benefit	Sum Assured on Death (as defined below) plus accrued Guaranteed Addition plus vested Reversionary Bonus, if declared plus Terminal Bonus, if declared
Option 3 – Child Future Secure	Sum Assured on Death (as defined below) plus accrued Guaranteed Addition plus vested Reversionary Bonus, if declared plus Terminal Bonus, if declared

Sum Assured on Death is 10.5 times the Annualized Premium;

The death benefit shall be at least 105% of the total premiums received till the date of death.

Where,

- (i) *Annualized Premium refers to premium payable in a year excluding taxes, any underwriting extra premium, rider premium and loading for modal premiums, if any.*
(ii) *Total premiums[^] paid mean total of all the premiums received by the Company, excluding any extra premium, any rider premium and taxes.*

[^]*In case of Benefit Option 3, the total premium will also include waived premiums, if any till the date of death of the Life Insured.*

- ii. The death benefit will be reduced by total premiums falling due and unpaid during the policy year in which the death occurs.
- iii. In case of death of the Life Insured during the policy term provided the policy is inforce but risk has not commenced, then the Company will pay the benefit in lumpsum equivalent to 105% of total premiums paid and the policy will terminate immediately.

b. Maturity Benefit

- i. On survival of the Life Insured till the end of the policy term provided this policy is in force, depending on the benefit option chosen by the Life Insured, the following benefits will be paid.

Option 1 - Income Benefit	Sum Assured on Maturity (as defined below)

	plus Terminal Bonus, if declared
Option 2 – Lumpsum Benefit	Sum Assured on Maturity (as defined below) plus accrued Guaranteed Additions plus vested Reversionary Bonus, if declared plus Terminal Bonus, if declared.
Option 3 – Child Future Secure	Sum Assured on Maturity (as defined below) plus accrued Guaranteed Additions plus vested Reversionary Bonus, if declared plus Terminal Bonus, if declared.

Sum Assured on Maturity = Guaranteed Maturity Benefit Factor x Annualized Premium/ 1000 x Premium Payment Term.

GMB Factors are provided in Annexure 1.

- ii. The contract will terminate on payment of Maturity Benefit.
- c. Cash Bonus (Applicable only in case of Benefit Option 1 – Income Benefit)
 - i. You will receive cash bonus, if declared by the Company based on the performance of participating fund. It will be payable annually on policy anniversaries starting from one year after end of Premium Payment Term till the end of the Policy Term, subject to the declaration by the Company.
 - ii. For policies under reduced paid-up status, the proportionate cash bonus will be payable, if declared by the Company provided premium for at least four consecutive full policy years have been paid.
 - iii. Cash bonus is calculated as a percentage of Sum Assured on Maturity. It is not guaranteed and may change from time to time.
- d. Waiver of Premium Benefit (Applicable only in case of Benefit Option 3 – Child Future Secure)
In case of death due to any cause or total & permanent disability due to accident of the policyholder (i.e. policyholder at the inception of policy) whilst the policy is in-force as on the date of the event, the policy will continue as in-force policy till surrender, maturity or death of the Life Insured, whichever is earlier, and the following benefits will be accrued and paid under the policy:
 - i. All future premiums post the date of event will be waived off and no future premiums are required to be paid under the policy
 - ii. Guaranteed Additions will continue to accrue as per in-force policy
 - iii. Simple Reversionary Bonus, if declared will continue to attach as per in-force policy
 - iv. Terminal Bonus, if declared will be payable along with Maturity benefit or Surrender benefit or Death benefit, whichever is earlier.

(Waiver of Premium benefits will trigger only in the event of death due to any cause or total and permanent disability due to accident of the initial Policyholder i.e. Policyholder at the inception of the Policy)

1(B). Other plan components

- a. Guaranteed Additions (Applicable in case of Benefit Option 2 – Lumpsum Benefit & Benefit Option 3 – Child Future Secure)

- i. Guaranteed Additions will accrue and be attached to the Policy at the end of each Policy Year starting from end of the first Policy Year till the end of Premium Payment Term provided the policy is in-force. The accrued Guaranteed Additions will be paid along with the Maturity benefit or Surrender benefit or Death benefit, whichever is earlier.
- ii. The Guaranteed Additions will accrue as per the rate given in the below table:

Guaranteed Addition Rate (GAR) per 1000 of Annualized Premium				
PPT	5	7	10	12

Where,

Guaranteed Additions = Guaranteed Addition Rate x Annualized Premium/ 1000 x No. of completed policy years for which Premium is Paid

- b. Simple Reversionary Bonus (Applicable in case of Benefit Option 2 – Lumpsum Benefit & Benefit Option 3 – Child Future Secure)

Based on the performance of the participating fund, the Company may declare the Simple Reversionary Bonus. The bonus, if declared will vest into all in-force policies at end of each policy anniversary starting from one year after end of Premium Payment Term till the end of the Policy Term.

The bonus is calculated as a percentage of the Sum Assured on Maturity and the vested bonus will be paid along with Maturity benefit or Surrender benefit or Death benefit, whichever is earlier.

The Simple Reversionary Bonus are not guaranteed and may change from time to time. However, once declared, they are then guaranteed. If your Policy is under Paid-Up status, no future reversionary bonus will be attached.

- c. Terminal Bonus

The Company may declare Terminal Bonus which shall be paid along with the maturity benefit or death benefit or surrender benefit, provided the policy is in-force. The bonus if declared, will be paid based on Benefit Option, Premium Paying Term, Policy Term and Sum Assured on Maturity. No Terminal bonus is payable if the Policy is under Reduced Paid-Up status.

2. Payment of Premium and Discontinuance of premium payment

- a. Premium payment

- i. You shall pay all premiums on the due dates during the Premium Payment Term under the Policy.
- ii. The premium can be paid through Yearly, Half Yearly, Quarterly or Monthly Mode as chosen by the Policyholder. For Quarterly and Monthly modes, the premium payments can be made only through National Automated Clearing House (NACH) / Standing Instruction (SI) payment mode.
- iii. For your premiums due in the given financial year, you have an option to make an advance payment of the due premiums within the same financial year. However, in case if your premium is due in the next financial year, the Company would accept such payments which are within a maximum period of three months in advance, from the premium due date.
- iv. Any advance premium received by Us, will be applied to your policy only on the premium due date.

- b. Grace Period

- i. To enjoy the plan benefits, it is essential that You pay the premiums regularly on or before the due date(s). If We do not receive the premium in full by the premium due date, then We will allow a Grace Period of 30 days for Yearly, Half Yearly, Quarterly mode and 15 days for Monthly mode from the premium due date, for payment of the premium.

- ii. In case of death of the Life Insured during grace period, the policy will be considered in-force and the Death Benefit (as defined above) will be paid after deduction of premiums then due and all premiums falling due during the policy year of death.
- iii. Under Benefit Option 3 - Child Future Secure in case of death or total & permanent disability due to accident of the Policyholder (i.e. policyholder at the inception of the Policy) during grace period, then the policy will be considered in-force and the Waiver of Premium Benefit (as defined above) will get triggered provided the premium due before the date of event are paid.

c. Lapsation

- i. Your policy will lapse if the due but unpaid premium is not received by the Company on or before the expiry of grace period for first two full policy years.
- ii. Life cover under lapsed policy will cease and no benefits are payable

d. Reduced Paid-up Benefit

- If all due premiums have been paid to the Company for at least first two full Policy Years and subsequent premiums are not paid, then the Policy will automatically be converted into a reduced paid-up Policy and will continue with the reduced paid-up benefits as stated below.
- Once your policy acquires reduced paid-up status, it will not be eligible for any future simple reversionary bonus, if declared, terminal bonus, if declared and guaranteed additions.
- In case you have opted for Benefit Option 3, it will not be eligible for Waiver of Premium benefit in the event of death due to any cause or total & permanent disability due to accident of the initial Policyholder while the policy is in reduced paid-up status.
- In the event of death of the Policyholder during minority of the Life Insured while the policy is in reduced paid-up status, the Company shall be informed for change of the Policyholder.
- The accrued benefits will remain attached to the policy and will be payable along with the benefits listed below, paid under the Policy.

i. Death Benefit under Reduced Paid-Up policy:

If the Life Insured dies during the Policy Term whilst the policy is in reduced paid-up status, we will pay the Paid-up Death benefit (as defined below) along with accrued Reversionary Bonus, Guaranteed Additions (applicable in case of benefit option 2 & 3) and the policy will terminate immediately.

Paid up Sum Assured on Death = Total number of premiums paid divided by Total number of premiums payable multiplied by Sum Assured on Death.

ii. Maturity Benefit under Reduced Paid-up policy

On survival of the Life Insured till the end of the policy term, the Paid-Up Sum Assured on Maturity (as defined below) along with the accrued Guaranteed Additions (applicable in case of benefit option 2 & 3) will be paid and the contract ceases immediately.

Paid –up Maturity Benefit = Total number of premiums paid divided by Total number of premiums payable multiplied by Sum Assured on Maturity

iii. On surrender of Reduced Paid- up policy

If the Life Insured surrenders the policy whilst the policy is in Reduced Paid-up status, the higher of Guaranteed Surrender Value (as defined below under Section 3) or Special Surrender Value will be payable and the contract gets terminated immediately.

Special Surrender value will be calculated using the basis and formula as approved by IRDAI. The Special Surrender Value may be amended by the Company from time to time with prior approval of IRDAI.

iv. Cash Bonus for Paid-up policy (Applicable in case of Benefit Option 1)

On survival of the Life Insured during the policy term, the Paid-Up Cash Bonus (as defined below) if declared will be payable, provided the premium for at least 4 consecutive years were paid

$$\text{Paid-up Cash Bonus} = \text{Paid-up Sum Assured on Maturity} \times \text{Cash Bonus rate, if declared}$$

e. How to revive your Lapsed/ Reduced Paid-Up Policy

You may revive the lapsed Policy or Reduced Paid-Up policy within five years from the due date of the first unpaid Premium by following these simple steps:-

- i. Submit a written request to the Company within 5 years from the due date of first unpaid premium.
- ii. Pay all outstanding Premium amount with interest at the prevailing interest rate.
- iii. Fulfilling all medical requirements as specified by the Company, if required. The cost of the medical examination will be borne by the Policyholder.

The prevailing interest rate is calculated as equal to 10 year G-sec benchmark interest rate as on last working day of the previous financial year +1.50%, rounded up to the next multiple of 25 basis points and will be compounded on half yearly basis. The 10 year G-Sec rate on 31st March 2022 was 6.84% and the rate of interest for revival for FY 22-23 is 8.50% (6.84% + 1.5% + rounding to next multiple of 25 basis points). Any change in basis shall be with prior approval of the Authority. The Company will review the revival interest rate on every 1st of April.

The revival will be effected on receipt of the proof of continued insurability and is subject to submission of Declaration of Good Health and Board approved underwriting policy of the Company applicable at that time. Once the Policy is revived, all benefits will be restored to its original benefit level.

PART D

3. **Surrender Value**

You may surrender the Policy at any time during the Policy Term provided the policy has acquired Surrender Value as per the benefit option chosen.

- i. Surrender Value payable will be higher of Guaranteed Surrender Value or Special Surrender Value. In case of Benefit Option 2 & 3, the Surrender Value will be inclusive of Terminal Bonus as well, if declared by the Company.
- ii. In case of Benefit Option 1 - Income Benefit, Guaranteed Surrender Value (GSV) is defined as following:

$\{\text{GSV Factor} \times \text{Total premiums paid till the date of surrender}\} \text{ less } \{\text{Cash Bonus already paid, if any}\}$

- iii. In case of Benefit Option 2 - Lumpsum Benefit and Benefit Option 3 – Child Future Secure, the Guaranteed Surrender Value (GSV) is defined as following:

$\{\text{GSV Factor} \times \text{Total premiums paid till the date of surrender}\} + \{\text{Bonus Factor} \times (\text{Accrued Guaranteed Additions} + \text{vested Reversionary Bonuses})\}$

GSV Factors and Bonus Factors are provide in Annexure 2.

- iv. Special Surrender Value (SSV) - Special Surrender value will be calculated using the basis and formula as approved by IRDAI. The Special Surrender Value may be amended by the Company from time to time with prior approval of IRDAI.
- v. Once the policy is surrendered, no further benefits will be payable.

4. **Termination of the Policy**

This Policy shall terminate on the occurrence of the earliest of the following:

- i. On Policy being lapsed and not revived within revival period.
- ii. On Surrender of the Policy, upon payment of applicable surrender value, if any.
- iii. On Death of the Life Insured, upon payment of Death Benefit, as applicable.
- iv. On Maturity of the Policy, upon payment of Maturity Benefit.
- v. On free look cancellation, upon payment of free look cancellation.

5. **Free Look cancellation**

You have a period of 15 days (30 days, if the policy is opted through Distance Marketing mode/ Policies issued in electronic mode) from the date of the receipt of this Policy Document to review the terms and conditions of this Policy. If you disagree to any of the terms or conditions of the Policy, then, You have an option to cancel and return this Policy Document to Us stating the reasons for such objections.

In such an event, this Policy shall terminate and You shall be entitled to a refund of the amount of premium paid subject to a deduction of a proportionate risk premium for the period of cover, any expenses incurred by Us on medical examination, if any and stamp duty charges.

Distance Marketing mode includes every activity of solicitation (including lead generation) and sale of insurance products through the following modes: (i) voice mode which includes telephone-calling (ii) short messaging service (SMS) (iii) electronic mode which includes e-mail and interactive television (iv) physical mode which includes direct postal mail and newspaper & magazine inserts and (v) solicitation through any means of communication other than in person.

6. **Alteration in Premium Payment Frequency**

During the Premium Payment Term, the Policyholder has an option to alter/ change the premium payment frequency as available under the policy. The Policyholder can exercise such option only on Policy Anniversary.

7. Policy Loan Facility

- i. You can avail loan from the Company, provided the policy has acquired surrender value, by assigning the policy document as a collateral security.
- ii. The loan can be availed upto 70% of Surrender Value at the applicable interest rate levied by the Company.

The prevailing interest rate is calculated as equal to 10 year G-sec benchmark interest rate as on last working day of the previous financial year +1.50%, rounded up to the next multiple of 25 basis points and will be compounded on half yearly basis. The 10 year G-sec rate as on 31st March 2022 was 6.84%. The rate of interest on loan for FY 2022-23 is 8.50% (6.84% + 1.5% + rounding to next multiple of 25 basis points).

- iii. The interest rate will be reviewed by the Company every year, and the revised loan interest rates will become applicable effective 1st April. The basis of calculation of loan interest rates may be revised by the Company from time to time depending on the then interest scenario in the market after obtaining prior approval from the Authority.
- iv. The loan outstanding along with the accumulated interest will be adjusted towards the future benefits including cash bonus, if declared & due or any other amount payable under the policy.
- v. For inforce and fully paid up policy: Policy can't be foreclosed on the ground of outstanding loan amount including interest exceeds the surrender value.
- vi. For other than in-force and fully paid up policies: The policyholder will be given written notice when the outstanding loan amount including interest is 95% of the surrender value. The policyholder may repay whole or part of the outstanding loan amount. At any point in time, if the loan outstanding along with accumulated interest exceed the applicable Surrender Value, the Policy will be foreclosed immediately and no benefits will be payable

PART F

8. **Suicide Exclusion**

In the event Life Insured commits suicide, whether sane or insane, within 12 months *from the date of commencement of risk or from the date of revival of the policy*, the Policyholder/ Beneficiary/ Nominee, shall be entitled to an amount which is higher of 80% of the 'Total premiums' paid till the date of death of the Life Insured or the Surrender Value available as on date of death of the Life Insured, provided the policy is in force.

9. **Exclusion for Accidental Total & Permanent Disability (Applicable for Benefit Option 3 - Child Future Secure)**

For Death Benefit, there are no exclusions other than suicide clause.

The waiver of premium benefit shall not be applicable in the event of disability of a Policyholder (i.e. policyholder at the inception of policy), occurred directly or indirectly due to any of the following reasons:

- i. Engaging or taking part in any professional sport(s) or any hazardous pursuits or pastimes, including diving or riding or any kind of race; underwater activities involving the use of breathing apparatus or not, martial arts; hunting, rafting, mountaineering, rock climbing, para-jumping, parachuting, bungee jumping.
- ii. Participation in any flying activity, except as a bona fide, fare-paying passenger of a recognized airline or Pilots and cabin crew of a commercial airline, on regular routes and on a scheduled timetable.
- iii. Self-inflicted injury or disability due to suicide attempt.
- iv. Policyholder being under the influence of drugs, alcohol, narcotics or psychotropic substances unless taken in accordance with the lawful directions and prescription of a registered medical practitioner.
- v. Service in any organization undertaking any military, police, air force, naval, paramilitary activities.
- vi. War, civil commotion, invasion, terrorism, hostilities (whether war be declared or not).
- vii. Criminal or illegal activity with a criminal intent.
- viii. Nuclear reaction, radiation or nuclear or chemical contamination.
- ix. Active participation in strikes, industrial dispute, riots, civil war, mutiny, rebellion, revolution, insurrection.

10. **Claims Processing**

- a. Maturity Claim - Following documents are required for processing the Maturity Claim.
 - i. Original Policy Document
 - ii. Advance Discharge Voucher
 - iii. Any other document as may be requested by the Company
- b. Death Claim - All Death Claims to be notified to the Company in writing by the Nominee /Beneficiary in the prescribed format provided by the Company, for registering a claim under this Policy along with the following documents:
 - i. Original Policy Document
 - ii. Claimant's statement/ claim form;
 - iii. Copy of Death certificate of the Life Insured from the municipal/local authorities;
 - iv. Copy of photo-identity proof of the claimant and supporting documents evidencing the rights of claimants;
 - v. Copy of the police panchnama, police inquest report and first information report in case of accidental death;
 - vi. Any additional information and documents required by the Company for assessing the validity of a claim and for processing a claim request.
- c. All benefits payable under this Policy will be paid by the Company in Indian rupees.

- d. A discharge or receipt by the Policyholder or the Nominee/ Beneficiary shall be a good, valid and sufficient discharge to the Company in respect of any payment made by the Company hereunder.
- e. Upon receipt of satisfactory proof of a claim under this Policy, the Company shall process the claim request.
- f. The Company may even consider payment of the claims without any documents and/or other requirements provided there are sufficient grounds to believe that the documents are destroyed completely and could not be retrieved due to causes like natural disaster (e.g. flood, earthquake etc) etc.

11. Disclosures

i. Assignment

Assignment should be in accordance to Section 38 of Insurance Act 1938, as amended from time to time.

13. Declaration relating to Mis-statement of Age

This policy contract has been issued on the basis of the admitted age in the Proposal Form/ Application form. In the event the stated age is found to be incorrect, the Company may initiate the following action:

- i. If age of Life Insured is found to be beyond the age band prescribed for this product, the policy will be cancelled and all the premiums paid will be refunded as per Section 45 of the Insurance Act 1938 as amended from time to time.
- ii. If the Correct Age of the Life Insured is found to be higher than the Admitted Age but the Life Insured remains eligible of being assured under this Policy then, subject to fresh underwriting, Basic Premium and Extra Mortality Premiums, if any will be recalculated as per the Correct Age from the Date of Commencement of Risk and the Policyholder shall pay to the Company the difference between the premiums paid and premiums payable as per the Correct Age together with interest at the applicable rate of interest.
- iii. If the Correct Age of the Life Insured is found to be lower than the Admitted Age, the Basic Premium and Extra Mortality Premium, if any will be recalculated as per the Correct Age from

the Date of Commencement of Risk and the Company shall refund, without interest, the difference between the premiums paid by the policyholder on the basis of the Admitted Age and the premiums calculated as per the Correct Age

14. Change of address

- i. By You - It is very important that You immediately communicate Us about any change of address or nomination to enable the Company to service this Policy effectively.

Annexure 3

Section 38- Assignment and Transfer of Insurance Policies

Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

1. This policy may be transferred/assigned, wholly or in part, with or without consideration.
2. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
3. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
4. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
5. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy thereof certified to be correct by both transferor and transferee or their duly authorized agents have been delivered to the insurer.
6. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
7. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
8. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
9. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
 - a. not bonafide or
 - b. not in the interest of the policyholder or
 - c. not in public interest or
 - d. is for the purpose of trading of the insurance policy.
10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment.
11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
 - a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
 - b. where the transfer or assignment is made upon condition that
 - i. the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR
 - ii. the insured surviving the term of the policy

Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.
14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
 - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
 - b. may institute any proceedings in relation to the policy
 - c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Act, 1938 as amended from time to time shall not be affected by this section.

Annexure 4

Section 39- Nomination by policyholder

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

1. The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
2. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.
3. Nomination can be made at any time before the maturity of the policy.

4. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
5. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
6. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.
7. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
8. On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof.
9. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.
11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).
13. Where the policyholder whose life is insured nominates his
 - a. parents or
 - b. spouse or
 - c. children or
 - d. spouse and children
 - e. or any of them
 the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.
14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).
15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Act 1938 as amended from time to time.
16. If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.
17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where before or after Insurance Act 1938 as amended from time to time, a nomination is made in favor of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.

Annexure 5

Section 45 – Policy shall not be called in question on the ground of mis-statement after three years.

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Act, 1938, amended from time to time are as follows:

1. No Policy of Life Insurance shall be called in question on any ground whatsoever after expiry of 3 yrs from
 - a. the date of issuance of policy or
 - b. the date of commencement of risk or
 - c. the date of revival of policy or
 - d. the date of rider to the policy
 whichever is later.
2. On the ground of fraud, a policy of Life Insurance may be called in question within 3 years from
 - a. the date of issuance of policy or
 - b. the date of commencement of risk or
 - c. the date of revival of policy or
 - d. the date of rider to the policy
 whichever is later.

For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

3. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy:
 - a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;

- b. The active concealment of a fact by the insured having knowledge or belief of the fact;
 - c. Any other act fitted to deceive; and
 - d. Any such act or omission as the law specifically declares to be fraudulent.
4. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak.
 5. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the policyholder, if alive, or beneficiaries.
 6. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.
 7. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignees of insured, within a period of 90 days from the date of repudiation.
 8. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.
 9. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
